 Historic Loveland Business Improvement District Update and next steps on dissolution of the Loveland Downtown Partnership – Sean Hawkins.

Hawkins updated on the steps to dissolve the Loveland Downtown Partnership and transfer the assets of the Loveland Downtown Partnership to the Historic Loveland Business Improvement District and DDA. Hawkins expected to bring a dissolution resolution for the board to consider at the January 2024 meeting.

Fire Line Contracts – Sean Hawkins.

Hawkins presented three fire line grant projects that had been reviewed and awarded by the Loveland Downtown Development Authority Board of Directors. Upon paying these grants, there would be a balance of \$143,532 in the fire line restricted account with a total of \$30,732 available for new projects.

Dannenbring a made a motion to approve the three fire line projects for 120 East 4<sup>th</sup> Street, 404 East 3<sup>rd</sup> Street and the Feed and Grain project as presented. Griesel second the motion which passed unanimously.

## **RESOLUTION LDP #R-1-2024**

A RESOLUTION APPROVING THE DISSOLUTION OF THE LOVELAND DOWNTOWN PARTNERSHIP AND TRANSFERRING OF THE ORGANIZATION'S ASSETS TO THE LOVELAND DOWNTOWN DEVELOPEMNT AUTHORITY AND HISTORIC LOVELAND BUSINESS IMPROVEMENT DISTRICT.

WHEREAS, in January, 2014, the City Council of the City of Loveland ("City Council") directed City staff to assist private sector leaders with the establishment of a robust and durable organization to lead redevelopment efforts in the City's downtown area; and

**WHEREAS**, in July, 2014, an informal coalition of private sector leaders known as the Downtown Working Group formulated *A Strategic Plan for Revitalizing Downtown Loveland* (the "Strategic Plan") which provides a comprehensive outline for the short- and long-term success of downtown; and

WHEREAS, on September 30, 2014, the Loveland Downtown Partnership ("LDP") was organized as a social welfare organization within the meaning of §50l (c)(4) of the Internal Revenue Code of 1986 to: (a) provide a means for persons interested in the development or redevelopment of the downtown to identify, discuss and act to address issues concerning the downtown; (b) coordinate activities, projects and programs which will enhance the downtown as a civic, cultural, social, and economic center and a place where people can live, work, conduct business and enjoy a better quality of life; (c) promote cooperation among the public and private sectors to promote the downtown; and (d) encourage the commitment of public and private resources to the planning and development or redevelopment and favorable marketing of the downtown; and

**WHEREAS**, on October 27, 2014, the LDP adopted the Strategic Plan and approved the boundaries of the downtown area (the "Downtown") and the City Council supported the Downtown Strategic Plan by Resolution #R-93-2014; and

WHEREAS, by Ordinance No. 5906 and Resolution #R-82-2014, the City Council called a special election on February 10, 2015 for the purpose of submitting a question regarding the establishment of the Loveland Downtown Development Authority (the "DDA") to the qualified electors of the Downtown and the qualified electors passed such ballot question and the DDA was thereby established; and

WHEREAS, the Historic Loveland Business Improvement District of the City of Loveland, County of Larimer, State of Colorado (hereinafter referred to as the "District"), is a duly organized and existing quasi-municipal corporation and political subdivision of the State of Colorado, existing and operating under and by virtue of the Constitution and laws of the State of Colorado, including but not limited to Part 12 of Article 25 of Title 31, C.R.S., as amended (the "Business Improvement District Act"); and

WHEREAS, A special election was conducted by mail ballot on November 7, 2023, within the Historic Loveland Business Improvement District at which election the eligible electors voted in favor on the levy of taxes and other matters as described in the ballot issues; and

WHEREAS, the LDP was intended to be the starting point of downtown revitalization efforts and with the successful establishment of the Loveland Downtown Development Authority in 2015 and the Historic Loveland Business Improvement District in 2023, the organization is no longer needed as part of Loveland's efforts to revitalize its downtown and will be dissolved; and

**WHEREAS**, the LDP has assets including cash, office equipment, cleaning equipment, event equipment and more. Upon dissolution of the LDP, these assets will be transferred to the Historic Loveland Business Improvement District and Loveland Downtown Development Authority.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE LOVELAND DOWNTOWN PARTNERSHIP:

<u>Section 1</u>. The Loveland Downtown Partnership shall be dissolved upon final transfer of all organization assets to the Loveland Downtown Development Authority and the Historic Loveland Business Improvement District.

<u>Section 2.</u> That the Executive Director is authorized, in consultation with the Loveland Downtown Partnership Board Chair and Loveland Downtown Development Authority Board Chair, to take all final steps needed to dissolve the organization including completing all outstanding payments to vendors, completing necessary tax filing documentation, cancelling insurance premiums, closing bank accounts and credit card accounts and other activities as needed to dissolve the organization.

Section 3. That this Resolution shall be effective as of the date of its adoption.
